



2017 Request for Proposals – Plumbing Services Habitat for Humanity of Pinellas County

Habitat for Humanity of Pinellas County, Inc. (Habitat) is seeking proposals from qualified contractors for **Plumbing** services for our homes located at various locations in Pinellas County, Florida. Habitat builds between 50 to 55 new houses a year.

SERVICE PROVIDER SELECTION

Selection of the provider shall be based upon: (a) prior experience with similar projects, (b) backgrounds and qualifications of the persons responsible for the work, (c) availability of maintaining an electronic communication, including but not limited to PDF format (d) cost of materials, and (e) schedule availability/lead time from when order is approved.

GENERAL TERMS & CONDITIONS

The Request for Proposals (RFP) does not commit Habitat to award a contract, to pay any cost incurred in the preparation of the firm's RFP response or procure contract services or systems. Habitat reserves the right to accept or reject any or all RFP responses received as a result of this request, to negotiate with all qualified sources and/or to cancel all or part of this RFP. Habitat also reserves the right to choose one or several suppliers and products.

AWARD

The company/entity chosen to provide such services may be required to participate in negotiations. Habitat reserves the right to select a service provider without discussion based upon the initial proposal.

REQUIREMENTS

The company/entity shall be required to execute a standard Agreement and provide proof of insurance, workers' compensation coverage (if applicable). If exempt, must provide exemption certificate. All faucets shall be **water sense** and **ADA** compliant.
